Net Worth as at 30 March 2024 was £625.1. No Restricted Payments were made in Q2 or during the Relevant Year. The Restricted Payment Maximum at 30 March 2024 was £89.5m and no calculation of the Further Restricted Payment Maximum was required.



## **Maintenance and Capital Enhancement**

The cumulative Maintenance Expenditure in the Relevant Year was £26.1m and the Relevant Period was £12.1m. The Required Maintenance Amount for the Relevant Year was £17.4m.

Capital Enhancement Expenditure of £1.7m was made in Q2, £6.7m in the Relevant Year and £2.9m in the Relevant Period.
