FCF DSCR was 1.6 times and the EBITDA to Debt Service ratio was 1.3 times for the Relevant Year and 1.8 times and 1.5 times respectively for the Relevant Period.

Net Worth as at 28 September 2024 was £682.7m. Restricted Payments of £8.7m were made in Q4 and during the Relevant Year. The Restricted Payment Maximum at 28 September 2024 was £135.4m and no calculation of the Further Restricted Payment Maximum was required.



Maintenance and Capital Enhancement

The cumulative Maintenance Expenditure in the Relevant Year was £23.2m and the Relevant Period was £11.1m. The Required Maintenance Amount for the Relevant Year was £17.6m.

Capital Enhancement Expenditure of £2.0m was made in Q4, £8.3m in the Relevant Year and £5.4m in the Relevant Period.

*Maintenance includes both capital items and items expensed through the profit and loss account.
